Dear Supervisor Gorin,

The Springs Municipal Advisory Council (Springs MAC) would like to summarize our activities and accomplishments over the calendar year of 2022-2023 and cumulative updates for you and other members of the Board of Supervisors. Our summary is drawn from the complete record of activities extracted from our meeting minutes.

Monthly Meetings- The Springs MAC generally convenes the second Wednesday of every month at 6:30pm. The meetings were held on Zoom until the March 2023 meeting which was held in person at the Sonoma Valley Unified School District Offices. We are able to offer a hybrid option for community members from this location.

Organizational year- The Springs MAC has been operational for four years. Since 2019 was the initial year following MAC formation, it was generally felt necessary by council members, staff, and the chair to request key county department heads or designates to appear before the Council to introduce themselves and provide an overview of their departments' organization, mission and key objectives for Councilmembers.

Roads Ad Hoc Report

The S.M.A.C. was tasked with suggesting roads for the 2024/2025 Pavement Preservation Program Priority Roads Lists—Springs Region. An Ad Hoc was formed comprised of Council member Lombard and Vice Chair Perot. A number of materials were supplied by the County to aid in determining which roads would be most useful to the Springs. The Paving Project History Map and the Current Conditions Map were the most helpful tools for the Ad Hoc.

The criteria that were used were population density, number of dwellings, apparent number of residents (doubling, tripling in some places). Concern over road conditions in evacuation routes, especially those with expected large volume and narrow lanes. Road width relative to the road conditions and opportunities to avoid hazards were deemed of concern, as well as traffic volume and parked cars. The Ad Hoc used personal knowledge of Springs roads and as well, drove a good number of roads to make visual assessments.

There are many roads in the Springs which need repair. We were told that realistically only 3-4 miles of roads would be chosen. Instead of suggesting more roads with the Council voting on the most needy, we created a short list of roads that seemed most needful. Council members made suggestions which were noted by Supervisor Gorin. The list was voted on and approved unanimously by the Council.
