  - a. Public Infrastructure
    - i. Operational Budget: on target with our approved budget. We have reached approximately 89% of our revenue & should collect the additional 11% in the next two months (events are picking up & Guerneville is rented out). Expenditures are higher than anticipated (utilities: electric, water & sewer were much higher this past quarter). Salaries are still an issue.

## 11. Capital Projects Update

## a. Current Projects:

#### i. Santa Rosa

 PG&E Sustainable Solutions Turnkey Program: water heaters replaced, recommended energy improvements will go to the Board on July 18.
 Includes aesthetic improvements, HVAC, solar & battery units – using Strategic Planning Funds. Awaiting Board approval.

#### ii. Petaluma

- Seismic upgrade is delayed due anomaly in bid documents, awaiting guidance from County Counsel if it needs to be rebid. Keith will keep Terry & Duane updated. Silver lining is the delay of bid may help us if we receive the grant funding.
- 2. Slated for water heaters before contractor issue. PG&E is looking for a qualified contractor.

### iii. Cloverdale

1. Added a pool cover on Capital Improvement Plan, due to be considered by the Board in July.

#### iv. Sonoma

1. HVAC upgrade for lobby & lounge. Contract has been negotiated, awaiting approved by SPI Director.

#### v. Cotati

1. No planned projects

#### vi. Sebastopol

1. Stove & fridge will be pulled from Capital Improvement Project Plan with Sebastopol's permission, additional repairs needed in the kitchen will remain. Freezer, dishwasher, water heater still need attention.

#### vii. Guerneville

Architect is ready, funds ready to award for building study to decide
whether to tear down & replace or build elsewhere. SPI Director needs
to review County Real Estate portfolio before a decision can be made
now that we have the Bank of America building. We are still identifying
available properties for the Sheriff as well – complicating the decision.

#### 12. New Business

- a. Free Access to Regional Parks for Veterans
  - Request for ad hoc committee to work with County Parks and United Veterans Council on gaining free state park access for Veterans (similar to Federal program). No volunteers.

  - Request for ad hoc committee to work on a state bond for funding to improve all veterans buildings in the state (bond initiative, work with state representatives).
