Commissioners Wood and McCorquodale were absent. Commissioner Ofra and Kaykas-Wolff abstained. Chair Fortino Dickson abstained as Chair. Motion passed.

5. OFFICER REPORTS AND ADMINISTRATIVE UPDATES

a. Chair Fortino Dickson reminded everyone that December meeting is cancelled.
 The holiday party will be on December 14th at 6pm. Location will be determined later.

b. Staff asked for a volunteer to write the Woman's History Month Gold Resolution for March to present at the BOS meeting. Commissioner Brown volunteered and will partner with staff to move it forward.

6. COMMISSIONER ANNOUNCEMENT

- a. Commissioner Blalock announced that she, commissioners Brown and Padian tabled at Our Bodies/ Ourselves Event hosted by Planned Parenthood and AAUW. Former Chair Quinn presented and will be sharing the slides from her presentation. AAUW-Petaluma would like to partner with the Commission on projects.
- b. Commissioner Blalock also announced that Human Trafficking Task Force is doing an event on January 10th from 4pm-7pm focused on human trafficking. There's no cost for the Commission and Commissioner Blalock would like to table there. She will send out more information. Commissioner Brown volunteered to table this event.
- c. Commissioner Diaz-Garcia attended the YWCA I Run event. She made connections with non-profits that focus on women and reproductive rights. She will invite them to present at a Commission regular meeting. She will email the list of contacts to Chair Fortino Dickson.
- d. Commissioner Shulman reported on the \$500 sponsorship for the book club event that was approved last month. She wanted to confirm that that sponsorship funds could be used for the location expense. The Commissioners agreed.

7. OPENINGS AND APPOINTMENTS

- a. Chair Fortino Dickson announced two openings in the 4th district. She met with Supervisor Gore and Jenny Chamberlain to informing them of the openings. They indicated that they are diligently searching for 4th District representation.
- b. The Commission welcomed Commissioner Kaykas-Wolff. Commissioner Kaykas-Wolff lived in Marin County but moved with her family to Sonoma County five years ago. She is a consultant who runs marketing programs for technology companies. She is a member of the San Francisco Ballet Auxiliary and is involved in the American Conservatory Theater and related childrens' activities.

8. AD HOC AND PROJECT UPDATES

a. Voices Report Ad Hoc announced that their report is on the website. The report is located under Data and Report section. The report will be highlighted in the County HR newsletter in December. Commissioner Gordon has shared the report with organizations. Mount Saint Mary's is working on the Spanish report is coming soon. The ad hoc will meet to discuss next steps.

- b. Reproductive Rights Ad Hoc had no new information to report. Commissioner Gordon suggested that the report be added to CSW website to provide access to the Community.
- c. Junior Commission Educational Project announced that they elected their officers. They will be sharing more on their social media avenues. They picked three ad hocs and the human trafficking ad hoc will include the topic of menstrual poverty.

b. Ad-Hoc and Project Budget Requests

- Voices Report Ad Hoc increased their budget request to \$3,103 instead of \$2,603. They are requesting more funds to complete the report in Spanish because the Mount Saint Mary's is charging \$2,500 to fix the format. The \$3,103 requested funds will cover the Spanish report formatting, printing the reports and marketing the reports.
- Reproductive Rights Ad Hoc is requesting \$2,500. By July, they will
 complete the County-wide picture of access to reproductive health
 resources of pharmacies. They need more support from Commissioners to

reach the other Supervisorial Districts, using the survey from the First District in selected high schools and focus groups. Once this step is completed, they will compile data including pharmacy survey into a FAQ for each District. Recommendations were made to reach out to alternative schools, girls in Juvenile Hall, community health centers, Verity, with the questionnaire.

• Community Engagement Working Group described their work plan. They will create 3-month event calendars and coordinate those events. Social media was added to this ad hoc after the workplan was submitted. They are requesting \$4,000 for 3-4 Sponsorships and tabling events, Districts meet and greet, and Women's March. They are also requesting \$1,500 for marketing materials, Facebook ads, and raffle materials. A total of \$5,500 is being requested; however, due to the total budget and postponing the Women's March to 2025, the total allocation is \$4,500, which includes\$3,000 for the sponsorship and events and \$1500 for marketing materials and advertisement.

Section 2-322. Number and Diversity – Appointing Authority – Terms – Limitations – Attendance – Compensation and Reimbursement.

1. Number and Diversity

The Commission shall consist of fifteen (15) members, each of whom shall have a commitment to fostering better human relations in Sonoma County. The Commission shall reflect and represent the racial, ethnic, and cultural diversity of Sonoma County.

2. Appointing Authority

The Commissioners shall be appointed and confirmed by the Board of Supervisors of Sonoma County. Three (3) Commissioners shall be appointed by each district Supervisor to represent the five (5) supervisorial districts of the County.

3. Appointments

Of the initial fifteen (15) appointees to the Commission, eight (8) appointees shall serve terms of three (3) years while the remaining seven (7) Commissioners shall each serve two (2) year terms. All subsequent appointments by the Board shall be for two (2) year terms. The Commission may make recommendations on subsequent appointments and the filling of vacancies.

4 Limitation on Terms

There is no limitation upon the number of terms for which a Commissioner may be appointed.

5 Attendance

A report may be made to the appointing Supervisor whenever a Commissioner fails to attend at least two-thirds (2/3) of the regular meetings held during any twelve (12) month period. Furthermore, Commissioners shall give an Officer or the Commission's staff prior notice if they cannot attend a regular meeting. The appointing Supervisor may remove the Commissioner for failure to comply with the attendance requirement.

UPDATE! The Brown Act: Teleconference Requirements

Suspension of Teleconference Requirements During the Pandemic

During the COIVD-19 pandemic, Governor Newsom passed a series of executive orders that relaxed the traditional Brown Act requirements for remote public meeting participation to protect public health. The Legislature, through its passage of AB 361, allows local agencies to suspend many of the Brown Act's rigid requirements for teleconferencing when a board or commission meeting is held during a declared state of emergency. Specifically, AB 361 amended the Brown Act to provide additional provisions that allowed far more flexibility to conduct remote public meetings of commissions and boards if the Governor continued to declare a state of emergency due to the COVID-19 pandemic. On September 28, 2021, in compliance with AB 361, the Sonoma County Board of Supervisors adopted Resolution 21- 0399 to make the required findings to allow remote meetings, and the Board has continued to make those findings every thirty days as required by state law.

The Governor recently announced that he will rescind the Emergency Proclamation related to the COVID-19 pandemic at the end of February 2023. As a result, as of March 1, 2023, the Brown Act's rigid teleconferencing requirements likely will no longer be suspended.

Assuming the Governor's Emergency Proclamation is rescinded as announced, <u>the County's boards and commissions should plan now to be prepared by March 1, 2023 to return to meeting in person</u>. The ability of any board or commission member to participate remotely after that date will require either (1) full compliance with the Brown Act's traditional rigid teleconferencing requirements — including posting all members' remote locations on agendas and making all of those locations publicly accessible; <u>or</u> (2) following new complex teleconferencing provisions added by Assembly Bill 2449 which go into effect on January 1, 2023.

Brown Act Teleconference Options Available on March 1, 2023

Option 1 – Traditional Brown Act Teleconference Requirements: The Brown Act allows a board or commission to use any type of teleconferencing in connection with any meeting. The Brown Act defines teleconference as a meeting of individuals in different locations, connected by electronic means, through either audio or video, or both. To conduct a meeting with a member participating by teleconferencing, the Brown Act requires the following:

- At least a <u>quorum</u> of the commission or board members <u>must participate from locations</u> <u>within the jurisdictional boundaries of the County</u>.
- Each teleconference location must be identified in the notice and agenda of the meeting.
- Agendas must be posted at each teleconference location in addition to the standard posting location.
- Each location must be accessible to the public.
- The agenda must provide the opportunity for the public to address the legislative body directly at each teleconference location.
- All votes must be by roll call.

Option 2 – Assembly Bill 2449: On September 13, 2022, Governor Newsom signed Assembly Bill 2449 (Rubio) into law adding an alternative teleconferencing provisions to the Brown Act effective January 1, 2023 until its sunset (or extension) on January 1, 2026.

AB 2449 provides complex alternative teleconference procedures to allow a minority of members of a legislative body to participate remotely without having to post agendas at all teleconference locations, identify all teleconference locations in the meeting agendas, or make each teleconference location open to the public under very specific circumstances:

- At least a <u>quorum</u> of the members of the legislative body <u>must participate in person</u> <u>from one physical location</u> identified on the agenda, which location must be <u>open to the</u> public and within the boundaries of the local agency.
- A member may only teleconference for publicly disclosed "just cause" or in "emergency circumstances" approved by the legislative body.
- The public must be able to participate remotely.
- A member may only teleconference for a limited number of meetings.
- All votes must be by roll call.

<u>See</u> attached Table for more details on AB 2449's specific requirements.

Remote Public Participation May Continue

State law continues to allow remote public participation (and note that use of AB 2449's alternative procedures <u>requires</u> remote public participation). If there are sufficient staff resources to allow this option, boards and commissions may choose to hold a hybrid meeting with all board members present (or teleconferenced using applicable Brown Act rules) plus a call in and/or a Zoom-type option for members of the public to participate remotely. Departments and agencies that support the boards and commissions should consider whether there are sufficient resources to continue to offer this remote participation option for the convenience for members of the public.

AB 2449 - Teleconferencing Requirements

"Just Cause"

Timing and Procedure

The member <u>notifies</u> the legislative body at the earliest opportunity possible (can be as late as the start of a regular meeting) of their need to participate remotely for "just cause," including a general description of the circumstances justifying their need to appear remotely.

Qualifying Reason

"Just cause" means any of the following:

- A childcare or caregiving need of a child, parent, grandparent, grandchild, sibling, spouse, or domestic partner that requires them to participate remotely
- A contagious illness that prevents a member from attending in person
- A need related to a physical or mental disability not otherwise accommodated for
- Travel while on official business of the legislative body or another state or local agency

Note: A member is limited to two virtual attendances based on "just cause" per calendar year.

"Emergency Circumstances"

Timing and Procedure

The member <u>requests</u> the legislative body as soon as possible to allow them to participate in the meeting remotely due to "emergency circumstances" and provides a general description of the circumstances justifying their need to appear remotely.

and

The legislative body takes action to approve the request. If the request does not allow sufficient time to place proposed action on such a request on the posted agenda for the meeting for which the request is made, the legislative body may take action at the beginning of the meeting in accordance with existing Brown Act provisions to add an item to the agenda.

Qualifying Reason

"Emergency circumstances" means a physical or family medical emergency that prevents a member from attending in person (does not require disclosure of any medical diagnosis or disability, or any personal medical information that is already exempt under existing law).

Note: The member must make a separate request for each meeting in which they seek to participate remotely.

Other Requirements

Under either "just cause" or "emergency circumstances":

- The member must publicly disclose at the meeting, before any action is taken, whether any other individuals 18 years of age or older are present in the room at the remote location with the member, and the general nature of the member's relationship with any such individual(s).
- The member must participate through both audio and visual technology (cannot turn off camera).
- Teleconferencing by a member may not be for a period of
 - o more than three consecutive months or 20 percent of the regular meetings for the local agency within a calendar year, *or*
 - o more than two meetings if the legislative body regularly meets fewer than 10 times per calendar year
- The public must be able to participate remotely through either:
 - A two-way audiovisual platform (defined to mean an online platform that provides participants with the ability to participate in a meeting via both an interactive video conference and a two-way telephonic function); and/or
 - A two-way telephonic service and a live webcasting of the meeting (defined to mean a telephone service that does not require internet access, is not provided as part of a two-way audiovisual platform, and allows participants to dial a telephone number to listen and verbally participate.
- All votes must be by roll call.


Whereas, Women's History Month is both a call to acknowledge outstanding women we know by name and to pay homage to the nameless women who shared our collective past



SUBJECT: Continuing the Commission's partnership and participation with the

SCHTTF

RECOMMENDED ACTION:

I recommend we discuss and vote on who would best fill this role when I leave, or whether the role will be filled at this time

BACKGROUND:

For the past 8 years I have been the liaison to the SCHTTF and have taken over the lead on the Education and Outreach Committee, filling an integral role due to my commitment to fighting human trafficking.

DISCUSSION:

I am leaving CSW- a replacement as liaison does not need to fill the leadership role I have taken on but would need to be committed to attending monthly meetings (4th Thursday of each month, 2-3pm in person or virtual) plus occasional committee meetings and participating in and furthering the goals and activities of the task force. CSW is not a service provider like most other partners, and so needs to provide other types of support. My concern is that no one from the Commission has taken the time to attend films we have shown or even that we have sponsored, attended panel discussions or any other event the task force has sponsored in recent years. This is a new group of Commissioners, so is there someone passionate about this subject?

- 1. Select a new liaison who has passion and interest in the work of the task force.
- 2. Temporarily keep Jan on in this role until someone else is ready to take it on. Jan can provide monthly reports to officers.
