1. Call to Order

- At approximately 8:45 A.M. the meeting was called to order by Chair Bill Arnone

2. Public Comment on Non-Agenda Matters

One member of the public spoke and informed the Board about water well contamination history of the Roseland area. The commenter asked how the former redevelopment funds are being used by the City of Santa Rosa to aid businesses within the Roseland community.

3. Approval of January 26, 2024 Meeting Minutes

5. Successor Agency Recognized Obligation Payment (ROPS) Business

Each city representative presented their respective ROPS report, including the administrative budget, and a representative from the County concluded the presentation. After the City of Cotati presented under Item 5.2, the Chair noticed that one of the required forms was missing. The Chair explained that the form is required in order for the Board to take action on the item. During the meeting, the form was retrieved by CDC staff and submitted to the Board.

Item 5.7 of the agenda, presented by the City of Santa Rosa staff, was heard in order and due to the nature of the item, a vote was taken by the Board prior to the other ROPS agenda items. The Board members asked clarifying questions to City staff and staff responded accordingly. There was one public comment on this item. The commenter expressed his appreciation to the Board for their questions and input.

The commenter asked if the upcoming increases in staffing costs, which was discussed by the County representative during their presentation, are associated with potential contamination and cleanup efforts within the Roseland redevelopment area.

The Chair explained that he has concerns with the certification as stated on each form, because he does not have personal knowledge that the amounts reported in each ROPS summary are true and accurate. He explained that the Board only needs to approve the ROPS for each jurisdiction and the signature certification is not required.

After conferring with County Counsel, the Chair asked for a second motion to approve the ROPS presented by each city and the county subject to consent by DOF to amend the summary form by striking out the certification language.

The presenter stated that the resolution form was provided by County staff. There was no public comment.

The Chair also requested sufficient time to review the entire agenda packet prior to any future meetings.

There was one public comment on this item. The commenter requested that a public packet in hardcopy format be available at least 72 hours before the meeting date.

Approval of Redevelopment Successor Agency Dissolution

The Town of Windsor Successor Agency (Agency) notified the California Department of Finance (Finance) of its January 24, 2025 Oversight Board (OB) resolution on January 30, 2025, requesting to dissolve the Agency. Pursuant to Health and Safety Code (HSC) section 34187 (d), Finance has completed its review of the OB action.

Based on our review and application of the law, OB Resolution 2025-10, approving the dissolution of the Agency, is approved. It is our understanding the Agency has met the conditions per HSC section 34187 (b) as follows:

- All enforceable obligations identified in the Recognized Obligation Payment Schedule have been retired or paid off.
- All real property has been disposed pursuant to HSC section 34181 or 34191.4.
- All outstanding litigation has been resolved.

Pursuant to HSC section 34187 (e), within 100 days upon receipt of this letter, the Agency shall dispose of any remaining assets as directed by the OB and proceeds from asset dispositions are to be transferred to the County-Auditor Controller. In addition, the Agency is to notify the OB of its compliance related to any remaining assets. Upon notification of the Agency's compliance, and within 14 days of verification, the OB shall submit to Finance a final resolution of the Agency's dissolution which shall be effective immediately.

OVERSIGHT BOARD RESOLUTION NO. 2025-

A FINAL RESOLUTION OF THE SONOMA COUNTY CONSOLIDATED OVERSIGHT BOARD APPROVING THE REQUEST TO DISSOLVE THE TOWN OF WINDSOR SUCCESSOR AGENCY PURSUANT TO HEALTH AND SAFETY CODE SECTION 34187(e)

WHEREAS, in 2012, the Redevelopment Agency of the Town of Windsor was dissolved, and the Town of Windsor ("Town") became its successor agency ("Successor Agency"); and

WHEREAS, in accordance with Health & Safety Code Section 34187(b), the Successor Agency shall submit to the oversight board a request, with a copy of the request to the county auditor - controller, to formally dissolve the successor agency within 30 days of meeting the following criteria: when all of its enforceable obligations have been retired or paid off, all real property has been disposed of, and all outstanding litigation has been resolved. The oversight board shall approve the request within 30 days, and shall submit the request to the Department of Finance (DOF); and

WHEREAS, by Resolution No. 2025-10, adopted on January 24, 2025, the Oversight Board approved the Successor Agency's request to dissolve and submitted the Resolution to the Department of Finance for approval; and

WHEREAS, by letter dated February 20, 2025, the Department of Finance approved Oversight Board Resolution No. 2025-10 approving dissolution of the Successor Agency; and

WHEREAS, in accordance with Section 34187(e), the Successor Agency has disposed of all remaining assets as directed by the Oversight Board and transferred all of its remaining assets in the amount of \$193,212.35 to the Auditor-Controller for distribution to the affected taxing entities pursuant to Section 34183; and

WHEREAS, on May 29, 2025, the Successor Agency notified the Oversight Board of its compliance with Section 34187(e); and

WHEREAS, on May 30, 2025, the County Auditor-Controller informed the Oversight Board that their office received the remaining assets from the Successor Agency and has distributed these funds to all affected taxing entities pursuant to HSC 34183; and

WHEREAS, the Oversight Board has verified all obligations of the Successor Agency have been retired or paid off, all outstanding litigation has been resolved, and all remaining assets have been disposed of, with the proceeds having been remitted to the County Auditor-Controller for distribution to the affected taxing entities, and desires to adopt this final resolution of dissolution for the Successor Agency, which shall be effective immediately.

NOW, THEREFORE, BE IT RESOLVED that the Consolidated Oversight Board hereby adopts this final resolution to dissolve the Town of Windsor Successor Agency pursuant to Health and Safety Code Section 34187(e).

BE IT FURTHER RESOLVED that the Clerk of the Oversight Board is directed to submit the final resolution to the Town of Windsor, the County Auditor-Controller, the State Controller's Office, and the Department of Finance by electronic means and in a manner of each entity's choosing.
