Director's Report/DHS-BH Budget Update/Updates of MH Systems Transformations Link to County of Sonoma, DHS-BH link: http://sonomacounty.ca.gov/Health/Be havioral-Health/	Bill Carter, SCBH Director	 Grant applications we sponsored are moving towards implementation which include partnering with the Elizabeth Morgan Foundation on Early Psychosis Intervention. The Mental Health Student Services grant is moving forward and we are partnering with the Sonoma County Office of Education. Both grants are from MHSOAC. This is the height of our contract season, we are working hard to get as many completed and updated for the new fiscal year. We are responding to the Board's requests for information as they are developing the budget. There are two budget hearings related to Department of Health Services on June 15th and June 22nd PHF- the opening date is still getting pushed back, the projected opening is the end of September and they will be able to admit clients the beginning of October. The PHF will have 16 beds which we will share with Marin County. Two beds will be on contract for Marin County and 14 for Sonoma County clients. The goal is for the PHF to alleviate

		anyone boarding in a hospital or CSU. Clients will be routed through CSU prior to going to the PHF. We will be partnering with Crestwood. The CSU is not currently staffed to run the 16 beds available due to staffing. We have the funds however staffing has been an issue. We hope recruitment efforts improve as COVID lifts.

In 2021 site visits were conducted at Progress Sonoma and Buckelew. The Progress Sonoma site visit was quite imaginative. The visit was conducted via Zoom; a staff person used her phone to "tour" the property. The visit was quite impressive, showing rooms, kitchens, and the outside areas to name a few. The Buckelew site visit was different however just as informative. The visit included a PowerPoint presentation by the CEO of Manor House, McBride and Petaluma Apartments. The PowerPoint included pictures of the inside, outside of the apartments, smoking areas, breakrooms and outside facilities. Very impressive. Introduction emails have been sent out to Thai Gallo of Community Support Network (CSN) to request site visits. Thai is the manager of Hope House and Brown Street. Hope House is a 12 bed men's board and care home.
