**Title:**

Health Services Fees

**Recommended Actions:**

Adopt a resolution establishing new and amended fees to recover the reasonable cost of providing services including fees associated with Environmental Health and Safety, Public Health Laboratory, and Sonoma County Animal Services for the Department of Health Services effective July 1, 2019.

**Executive Summary:**

The Department of Health Services is proposing new and amended fees effective July 1, 2019 for services associated with Environmental Health and Safety, Public Health Laboratory, and Sonoma County Animal Services. The Board of Supervisors is authorized to establish fees to recover the reasonable cost of providing certain services. Fees are imposed for a specific benefit conferred or service provided directly to the payor that is not provided to those not charged, and which do not exceed the reasonable costs to provide the benefit or service. Fees are also imposed for reasonable regulatory costs including enforcement inspections, investigations, and audits. It is the Department's practice to conduct outreach and communicate with those impacted by a proposed fee increase.

**Discussion:**

**Environmental Health and Safety Fees**

Environmental Health and Safety programs, as mandated through Health and Safety Code, promote health and quality of life by preventing or controlling those diseases that result from interactions between people and the places they live, work, and play. Environmental Health and Safety programs employ several strategies to prevent health hazards including education, trend surveillance and analysis, routine inspections, response to citizen tips, sampling and posting, and enforcement where necessary. Environmental Health and Safety charges fees to recover its costs to provide these services to members of the public who receive permits and benefit from Environmental Health and Safety's services.

The hourly rate is the primary factor used in computing the costs of providing Environmental Health and Safety services to the members of the public who receive these services. Annually, Environmental Health and Safety conducts an hourly rate cost analysis in order to determine full cost recovery necessary to fund the delivery of services for all programs. In fiscal year 2019-2020, the full cost recovery hourly rate is \$208. Realizing that a ten percent (10.0%) increase in the hourly rate may burden facility operators, Environmental Health and Safety is proposing to increase the hourly rate by 4.8 percent from \$188 to \$197 and utilize fee

stabilization funds to make up the funding gap. For fiscal year 2019-2020, the effect of the hourly rate change is an increase in revenue of \$335,568 (4.8%) over fiscal year 2018-2019 revenue.

The total cost of fee based programs is covered entirely by fees. Detailed Environmental Health and Safety services fee information is provided in Attachment 2.

### **Public Health Laboratory Services Fees**

The Public Health Laboratory provides clinical, environmental, and rabies testing services as mandated by Health and Safety Code 101150. These fee-based testing services aid doctors, hospitals, acute care facilities, environmental health agencies, and Sonoma County Animal Services in diagnosing and performing enforcement duties. The Laboratory also serves a regional role, providing the same services to Mendocino County through a flat-fee contract that is adjusted annually to recover the cost to provide this service.

Public Health Laboratory fees are set at below full-cost recovery amounts and are subsidized with Realignment funding. Providing market-rate, subsidized services to the public and non-government organizations allows the Department to recover a portion of the cost of operating the laboratory by performing tests that meet a public benefit or would otherwise be taken to private labs.

The Department is proposing 4.5 percent increases to all Public Health Laboratory fees to recover increased labor costs. The overall increase in revenue for fiscal year 2019-2020 Public Health Laboratory services is estimated at \$64,060. Detailed Public Health Laboratory services fees information is provided in Attachment 3.

### **Sonoma County Animal Services Fees**

Sonoma County Animal Services (Animal Services) provides sheltering and field services to areas within their jurisdiction, including unincorporated areas of the County, the City of Santa Rosa, and the town of Windsor. Animal Services is also responsible for rabies control for the entire County. The Animal Services' service area is comprised of approximately 1,575 square miles with nearly 500,000 residents and includes an animal shelter that serves nearly 3,300 animals annually.

The Department is requesting fiscal year 2019-2020 fee adjustments of 3.7 to 5.0 percent for some services provided by Animal Services to recover increased costs to deliver the services. Fees are imposed for a specific benefit conferred or service provided directly to the payor that is not provided to those not charged, and which do not exceed the reasonable costs to provide the benefit or service. Fees are also imposed for reasonable regulatory costs including enforcement inspections, investigations, and audits. The net increase in fee revenue for fiscal year 2019-2020 services is estimated at \$39,592. Detailed Animal Services fees information is provided in Attachment 4.

### **Prior Board Actions:**

On June 5, 2018 the Board adopted a resolution establishing new and amended fees to recover the reasonable cost of providing services including fees associated with Environmental Health and Safety, Public Health Laboratory, and Animal Services for the Department of Health Services effective July 1, 2018.

### Resolution of the Board of Supervisors of the County of Sonoma, State of California, Adopting New and Amended Fees Effective July 1, 2019 to Recover the Reasonable Cost of Providing Health Services

**Whereas**, the Board of Supervisors is authorized to establish fees to recover the reasonable cost of providing certain health services.

**Now, Therefore, Be It Resolved** that to recover the reasonable cost of providing certain health services, it is necessary to increase certain fees and establish certain new fees as set forth below.

**Be It Further Resolved**, based on information presented to this Board, this Board finds that the proposed fees comply with all legal requirements, including Art. XIII C of the California Constitution.

**Be It Further Resolved** that in all other respects, Resolution No. 18-0232, dated June 5, 2018, setting fees effective July 1, 2018, and any fee modifications established by subsequent resolution, shall remain in full force and effect.

**Be It Further Resolved** that if any section, subsection, sentence, clause or phrase of this resolution is for any reason held to be unconstitutional or otherwise invalid, such decision shall not affect the validity of the remaining portion of this resolution.

**Be It Further Resolved** that the following decreased fees, increased fees and new fees for health services are hereby adopted effective July 1, 2019.

**Environmental Health and Safety**

Environmental Health and Safety (EHS) programs promote health and quality of life by preventing or controlling those diseases that result from interactions between people and the places they live, work, and play. EHS programs employ several strategies to prevent health hazards including education, trend surveillance and analysis, routine inspections, response to citizen tips, sampling and posting, and enforcement where necessary. EHS charges fees to recover its costs to provide these services to members of the public who receive permits and benefit from EHS's services.

**Fee Methodology – Hourly Rate:** The hourly rate is the primary factor used in computing the cost of providing EHS services to the members of the public who receive these services. Annually, EHS conducts an hourly rate cost analysis in order to determine full cost recovery necessary to fund the delivery of services for all programs. In FY 19-20, the full cost recovery hourly rate is \$208. Realizing that a ten percent (10.0%) increase in the hourly rate may burden facility operators, EHS is proposing to increase the hourly rate by 4.8% from \$188 to \$197 and utilize fee stabilization funds to make up the funding gap. For FY 19-20, the effect of the hourly rate change is an increase in revenue of \$335,568 (4.8%) over FY 18-19 revenue.

**Proposed Fee Changes:** The Department of Health Services is recommending the addition of the following Environmental Health and Safety fees for FY 19-20.

**Food Safety**

**1. Food Facility – Permanent Facilities; Food Facility – Caterer (Local Limited Producer)**

A Local Limited Producer (LLP) prepares Non-Potentially Hazardous food items, such as baked goods, in an approved commercial kitchen and conducts local food sales. This category would bridge the gap between Cottage Food Operations, Processed Food Registrations (PFR), Temporary Food Facilities (TFF), and Catering Operations. The operator of an LLP would prepare and store food in a permitted commercial kitchen and retail food directly to the public in Sonoma County. This would allow small business operators that currently retail their food only at the farmer's market to take orders and retail their food outside of the farmer's market. Inspections would be conducted at the commercial kitchen once per year, and in response to complaints. Estimated additional revenue from this fee is \$1,182.

**2. Food Facility – Permanent Facilities; Food Facility – Host Facility**

In 2018, AB 2524 was passed and implemented on January of 2019. This law modifies California Retail Food Code to include catering operations and host facilities within the definition of a food facility, allowing for host facilities to provide direct food sales. A host facility is defined as a facility located in a brewery, winery, or commercial building, or another location as approved by Environmental Health, which meets applicable requirements to support a catering operation that provides food directly to individual consumers for a limited period of time, up to 4 (four) hours in any one 12 (twelve) hour period. Having a permit as a Host facility allows facilities not currently permitted for food

service to provide food to their customers and employees. Estimated additional revenue from this fee is \$1,034.

**3. Food Facility –Host Facility Plan Review (+ hourly rate after 2 hours)**

As part of the permitting process a review of building plans is required prior to construction of the facility. The facility requirements are less extensive than a permanent food facility and adapted to accommodate the catering operations outlined in AB 2524 and the California Retail Food Code. Estimated additional revenue from this fee is \$826.

**4. Food Facility –Host Facility Site Review (+ hourly rate after 2 hours)**

A construction review (Site Review) is conducted after the facility has been built to the approved plans and prior to the opening of the host facility to assure compliance with California Retail Food Code. Estimated additional revenue from this fee is \$826.

**5. Limited Charitable Feeding Operations**

In 2018, AB 2178 was passed and implemented on January 2019, adding a new definition to California Retail Food Code for a Limited Service Charitable Feeding Operation. A Limited Service Charitable Feeding Operation is defined as an operation for food service to a consumer solely for providing charity that is conducted by a nonprofit charitable organization. To create equity in service fees the following categories were created. Estimated additional revenue from these fees is \$2,012.

- **Limited Service Charitable Feeding Operation - Prepackage, No Prep, Non-PHF**  
Distribution of 100% prepackaged, shelf-stable foods
- **Limited Service Charitable Feeding Operation - Prepackage, No Prep, PHF**  
Distribution of 100% prepackaged, shelf-stable and perishable foods
- **Limited Service Charitable Feeding Operation - Minimal Preparation**  
Reheating and/or portioning commercially prepared foods with no further processing
- **Limited Service Charitable Feeding Operation - Moderate Preparation**  
Reheating and/or portioning commercially prepared foods
- **Limited Service Charitable Feeding Operation - Extensive Preparation**  
Heating, portioning, or assembly of a small volume of commercially prepared foods or ingredients that are not prepackaged

**Water Systems**

**1. State Small Water System Plan Check (+hourly rate after 2 hours)**

A separate plan review category is needed to track time and activities related to Small Water System plan review and recover appropriate fees. Estimated additional revenue from this fee is \$388.

**2. State Small Water Systems Site Review (+hourly rate after 2 hours)**

A separate plan review category is needed to track time and activities related to Small water System plan review and recover appropriate fees. Estimated additional revenue from this fee is \$388.

**Productivity, Efficiency, and Customer Service Improvement Plan for Environmental Health and Safety**

- Sonoma County is an Approved Milk Inspection Service (AMIS) County for the California Department of Food and Agriculture (CDFA). Currently, Sonoma County is one of five AMIS counties that conduct milk and dairy inspections within their jurisdiction. All other milk and dairy inspection services are conducted by the State (CDFA). The Milk and Dairy program has consistently had a cost greater than that of the revenues collectable by the allowable service fees set by the State. In 2019, a detailed analysis will be conducted of the Milk and Dairy program to determine if there are any additional efficiencies that can be implemented to balance this programs budget, minimize the draw on fee stabilization and/or determine if this program should be returned to the State.
- Continue implementation and quality improvement for the development of programs over the next several years to expand community awareness and increase accessibility of education including community outreach, program redevelopment, fee analysis, industry advisory groups, website development, and social media resources.
- Expand the EHS website for all programs to provide a more intuitive and user-friendly approach for search results and information.
- Implement, monitor and continue to improve upon the color-coded placarding program and website to best serve the community.
- Evaluate and provide recommended actions for the mobile food facility program. Pilot a data collection project to determine the needs of the program and industry education and outreach.
- Expand utilization of Envision Connect software to maximize business process efficiencies, data reporting capabilities and quality assuredness throughout all EHS programs. Develop a system for online application and payment submittals to increase customer convenience and efficiencies.
- Evaluate and restructure programs to enhance workflows, increase community engagement, establish industry advisory groups, and inform and educate the public.
- Continue evaluation of data quality, grants, workloads, fees and budgeting status reports to monitor expenditures and revenue.
- Develop a dedicated training plan and succession planning to encourage growth and expansion of the environmental health profession in Sonoma County.

**Summary of Expected Results**

- Increased awareness and engagement throughout the community of the EHS programs, profession and services provided.
- Sustainable work force and succession plan to encourage professional growth.

**Public Health Division – Public Health Laboratory Fees**

The Public Health Laboratory provides clinical, environmental, and rabies testing. These fee-based testing services aid doctors, hospitals, acute care facilities, environmental health agencies, and Sonoma County Animal Services in diagnosing and performing enforcement duties. The Laboratory also serves a regional role, providing the same services to Mendocino County through a flat-fee contract that is adjusted annually.

Revised fees are requested to recover increased labor costs that have increased 4.5%. The Department is proposing 4.5% percent increases to all Public Health Laboratory fees.

Public Health Laboratory fees are set at below full-cost recovery amounts and are subsidized with Realignment funding. Providing market-rate, subsidized services to the public and non-government organizations allows the Department to recover a portion of the cost of operating the laboratory by performing tests that meet a public benefit or would otherwise be taken to private labs.

**Proposed Additions to the Public Health Laboratory fee schedule:**

Microbial Disease Laboratory; QuantiFERON (TB screening): This tuberculosis screening assay is added to the test menu to support County Disease Control activities and potentially provide the service to local hospitals. The fee of \$35 is based on a reagent cost analysis and is competitive with private lab fees. Estimated additional revenue for this test is \$700.

Gene Sequencing to identify all bacteria, yeast, fungus, and Mycobacteria: The fee of \$94 is based on analysis of the cost to provide the service and consideration of the market rate for similar service. Estimated additional revenue for this test is \$1,034.

Virus Laboratory: RSV or Influenza A-B: The fee of \$94 is based on analysis of the cost to provide the service and consideration of the market rate for similar service. Estimated additional revenue for this test is \$20,116.

Virus Laboratory; CDC Trioplex (Chikungunya, Dengue, Zika): The fee of \$94 is based on analysis of the cost to provide the service and consideration of the market rate for similar service. Estimated additional revenue for this test is \$17,484.

Other; Shipping & handling: The fee of \$30 is based on analysis of the cost to provide the service and consideration of the market rate for similar service. Estimated additional revenue for this test is \$2,400.

**Changes to Existing Public Health Laboratory Fees:**

**Environmental Laboratory**

All existing test fees are increased by approximately 4.5% due to increased labor costs, resulting in an estimated \$10,007 additional revenue.

**Microbial Disease Laboratory**

All existing test fees are increased by approximately 4.5% due to increased labor costs, resulting in an estimated \$7,296 additional revenue.

**Virus Laboratory**

All existing test fees are increased by approximately 4.5% due to increased labor costs, resulting in an estimated \$3,786 additional revenue.

**Molecular Laboratory**

All existing test fees are increased by approximately 4.5% due to increased labor costs, resulting in an estimated \$1,237 additional revenue.

***The overall increase in revenue for FY 19-20 Public Health Laboratory services is estimated at \$64,060.***

**Productivity, Efficiency and Customer Service Improvement Plan for Public Health Laboratory**

- Complete an electronic laboratory report connection with regional hospital partners by executing a contract with a federally licensed Health Information Exchange, to drive laboratory results directly into patient files.
- Streamline and standardize internal procedures and workflows to improve efficiency and quality of customer service. For example, the lab shared drive was reorganized and staff now save documentation pertinent to lab operations on this drive, accessible to all. A group email was instituted for outside clients to use, improving communication lines.

**Summary of Expected Results**

- The Public Health Laboratory will be linked electronically to hospital partners to provide health test information in a timely and reliable manner.
- Improved communications, efficiency, and improved level of customer service.

**Summary of Results of Prior Year Plan**

- Reorganization of the lab shared drive enabled the new lab director to easily find lab documents pertaining to lab operations. Communications from clients on the group email are attended to promptly by staff when the point person is not available.

**Public Health Division - Sonoma County Animal Services Fees**

Sonoma County Animal Services (Animal Services) provides sheltering and field services to areas within their jurisdiction, including unincorporated areas of the County, the City of Santa Rosa, and the town of Windsor. Animal Services is also responsible for rabies control for the entire County. Animal Services' service area is comprised of approximately 1,575 square miles with nearly 500,000 residents and includes an animal shelter that serves nearly 3,300 animals annually. The Department is proposing fee revisions for animal impounds, vaccinations, licenses, and boarding fees.

The proposed Animal Services fees recover increased costs associated with services delivery, including costs charged to the Department by general government and those associated with salary and benefits. Fees are imposed for a specific benefit conferred or service provided directly to the payor that is not provided to those not charged, and which do not exceed the reasonable costs to provide the benefit or service. Fees are also imposed for reasonable regulatory costs including enforcement inspections, investigations and audits. Revised fees are requested to recover the reasonable cost to provide these services which is generally a 4.5 percent cost of living increase since Animal Services fees were last revised effective July 1, 2018.

The Department is proposing 3.7 to 5.0 percent increases to the Animal Services fees as described below. Percentage increases are as close as possible to 4.5 percent to recover the reasonable cost to provide these services

**Changes to Existing Animal Services Fees:**

**Animal Impound and Board Fees**

Animals are impounded at the animal shelter for a number reasons. Strays whose owners cannot be determined by animal control staff in the field by an identification tag or microchip are brought to the shelter for safe-keeping. Animal control officers responding to law enforcement requests for assistance may impound animals in the possession of owners being taken into custody. Members of the public often capture and transport strays to the animal shelter. Owners may surrender their animals when they are no longer able to care for their pets, or the death of an owner may force the animal into the care of the shelter. Animals that have bitten may be impounded at the shelter and quarantined to determine if the animal has rabies.

Costs of impoundment may include, but are not limited to, intake administration, veterinary examination and treatment, vaccinations, flea treatment, and preparation of a clean, warm kennel to house the animal. Costs of board include feeding, kennel cleaning, and ongoing veterinary care as needed.

**Impound - Cat Altered** – The fee increase from \$22.00 to \$23.00 will result in \$43.00 in additional revenue and 14.9 percent cost recovery.

**Board Per Day - Dog** – The fee increase from \$22.00 to \$23.00 will result in \$319.00 in additional revenue and 59.8 percent cost recovery.

**Board Per Day - Cat** – The fee increase from \$22.00 to \$23.00 will result in \$33.00 in additional revenue and 59.8 percent cost recovery.

**Board Per Day - Livestock** – The fee increase from \$22.00 to \$23.00 will result in \$7.00 in additional revenue and 59.8 percent cost recovery.

**Board Per Day - Rabies Quarantine** – The fee increase from \$27.00 to \$28.00 will result in \$34.00 in additional revenue and 72.8 percent cost recovery.

**Dog License Fees**

California Health and Safety Code Section 121690 states that every dog owner, after the dog reaches the age of four months, shall have it vaccinated for rabies and shall secure a license for the dog as provided by ordinance of the responsible city or county. Sonoma County Code Chapter 5 requires a dog owner to apply for a dog license within thirty (30) days after the dog is vaccinated for rabies. Dog licensing is an integral component of the Sonoma County Animal Services rabies prevention strategy as licensing data is used to report compliance with state rabies vaccination requirements.

**License - Dog Altered** – The fee increase from \$26.00 to \$27.00 will result in \$17,548.00 in additional revenue and 68.1 percent cost recovery. The requested increase recovers the 3 percent cost of living increase while maintaining a cost structure consistent with comparable counties.

**License - Dog Altered - Senior Citizen** – The fee increase from \$13.00 to \$13.50 will result in \$2,499.00 in additional revenue and 34.0 percent cost recovery. The requested increase

recovers the 3 percent of the cost of living increase while maintaining the 50 percent senior citizen discount structure.

**License - Dog Unaltered** – The fee increase from \$100.00 to \$104.00 will result in \$10,888.00 in additional revenue and 60.1 percent cost recovery. The requested increase recovers the 4.5 percent cost of living increase.

**License – Late License Penalty** – The fee increase from \$40.00 to \$42.00 will result in \$2,122.00 in additional revenue. The requested increase recovers the 4.5 percent cost of living increase.

**Kennel/Pet Shop License Fees**

**Kennel License - Commercial Kennel** – The fee increase from \$201.00 to \$210.00 will result in \$279.00 in additional revenue. The requested increase recovers the 4.5 percent cost of living increase.
