A. **Fish & Game Case Review and Filings.** Discussion with Sonoma County District Attorney Jill Ravitch and Sonoma County Agricultural Commissioner/Sealer of Weights & Measures Andrew Smith regarding Fish & Game case review and filings through the Sonoma County District Attorney's office. Ms. Jill Ravitch shared that the Environmental Consumer Law Division (ECLD) of the Sonoma County District Attorney's Office is fully staffed and ready to receive cases from CDFW. Ms. Ravitch also discussed how multiple natural disasters and the ongoing pandemic have impacted the court system, an overview

of cases referred to the District Attorney's Office in the past three years, how case fees are distributed, how or why a case might be downgraded from a misdemeanor to an infraction, and tracking infractions. The Fish & Wildlife Commission shared it is imperative that local CDFW wardens have a contact within the Sonoma County District Attorney's Office. Ms. Ravitch and Mr. Smith agreed to move forward with coordinating regular meetings between ECLD and CDFW. Ms. Ravitch will provide an update on steps taken to coordinate meetings by the next FWC meeting scheduled April 21, 2022.
